- 8. I understand and agree that any fees, costs or charges (including but not limited to Real Time Gross Settlement or Wire Transfers) howsoever incurred by JN Bank as a result of effecting my request herein will be borne solely by me.
- 9. I agree to indemnify and hold harmless the JN Bank, or its agents, employees, subsidiaries and affiliates against any suit, liability, loss, charge or expense, of any kind or of any nature whatsoever, including attorney's fees, which I may incur by virtue of the JN Bank, acting on this these instructions from me.
