Instructions for registering for a 3rd party transfer on JN Bank LIVE Personal

Step 1: After logging in you'll be prompted with JN Banks's Financial Services Agreement.

IN Bank"s E - Financial Services Agreement (test mari23/11/21)	
This Agreement governs the use of the JN Bank Limited's Electronic Channels ("the E-Services") and is made and entered into by and between the JN Bank Limited ("the Bank") and the holder of an Account with the Bank ("you").	ł
Definitions	
"Account" means any account held by you with the Bank and shall include any account so held jointly with any other person(s) "Business Day" means any day on which the Bank's offices and branches are open to the Public for business. "Basecode" refers to the pactiver(c) or scores code (c) chosen and used by you to accose the E Somisor.	
"Payee" means the individual, merchant, agency, or institution that has been approved by the Bank to be paid electronically via the E-Services hereunder or the individual, merchant, agency, or institution that has been approved by the Bank to send funds or Bills (where applicable) electronically to you via the E-Service hereunder.	
"Payment" means instructions from you to the Bank for a transfer of funds to a Payee or Third Party Account(s) via the E-Services hereunder and such instructions shall include but not be limited to the Payee"s name, the Payee"s account number, and the Scheduled Payment Date. The Bank will process these Payments using simply the account number provided and no further verification (such as account names, type or any other information relating to the receiving account) will be done by the Bank. "Payment Account" means the Account from which Payments will be debited.	
"Scheduled Payment Date" means the date that you want a Payee to receive your E-Bill Payment and is also the date that your Payment Account will be debited, however if the Scheduled Payment Date falls on a non-Business Day then the previous Business Day will be deemed to be the Scheduled Payment Date.	
"Third Party Account(s)" Means your other account(s) as may be maintained with other bank(s), Affiliates, Institutions, or accounts maintained by third parties with the JN Bank.

Step 2: After reading the agreement, click on I agree checkbox then select ok.



N.B. You can have this Agreement sent to your email by select "I wish to receive the Legal Agreement by Email".

Step 3: To unlock all Third-Party transactions navigate to the top right of the dashboard and click on the link "click here".



N.B. All Third-Party Transaction type functions will be unavailable and displayed with grey colored tiles until you have agreed to the Third-Party Agreement.

Step 4: Once on the Third-Party Agreement page select "I Agree" which will then have you proceed to a confirmation response stating that "You have accepted the Terms of Agreement".

the notification banner removed.
